EXTRACTS FROM THE CONSTITUTION OF CUAAV

The Objectives of the Association

- 1. To promote the University of Colombo as a pre-eminent institution providing relevant and challenging undergraduate and post-graduate education, including research, and professional training.
- 2. To guide and assist graduates of the University to obtain postgraduate qualifications and employment.
- 3. To foster the ongoing professional development of members through the provision of activities of interest.
- 4. To provide a mutually beneficial link between students, graduates and the business community.
- 5. To promote fellowship and networking between members
- 6. To assist in the welfare of the members
- 7. To provide regular information on scheduled events, relevant association and University matters and updates in education and professional training.
- 8. To affiliate, coordinate and work with the Alumni Association of the University of Colombo in Sri Lanka and help in its activities wherever possible.
- 9. To formulate and uphold other objectives reasonably necessary to promote its main objectives

Membership Categories

- 1. Full Member must be one of the following.
 - (a) A graduate of the University of Colombo or a person who has obtained a Post Graduate qualification from the University of Colombo.
 - (b) A graduate of a recognised university who has been an Associate Member of CUAAV for a continuous period of three years.
- 2. Associate Member must be one of the following.
 - (a) A past student of the University of Colombo who is not a graduate.
 - (b) A graduate of a recognised university other than the University of Colombo.
 - (c) A member of the Academic, Administrative or Non-Academic staff, a member of the University Court or University Council.
